keep us on schedule for all events. Sometimes they even remind me to pack my feed for lunch just in case we get a little behind in the race of the day.



INJURY ON THE JOB

Carriers get hurt everyday at work but are unaware of what they are required to do depending on their injury. The newer carriers have the fear of being fired or reprisal for filing a claim. It is always better to file claim when it involves serious injuries. Majority of injuries for carriers fall under traumatic category and require a Form CA-I. Normally these forms were obtained from your Supervisors and had to be completed in 30 days but now they available online on ECOMP. The urgency for completing the CA-1 is to ensure it reaches OWCP for approval and the carrier receives continuation of pay if need be. You will be responsible for ensuring all medical evidence is submitted to the OWCP. This includes the detail description of your job. The doctor's notes of your injury and detailed list of do's and don'ts you will be allowed to do at work.

In most traumatic injuries, carriers should ask for a CA-16 (Authorization for Examination and/or Treatment) and be given one within 4 hours from your Supervisor. CA-16s must be approved by an authorizing Supervisor and be completed by the doctor and then sent to OWCP for processing. It should be noted that Post Office no longer has any control in deciding the outcome of the claim.

One point the Supervisor never seems mention to carriers is that they have the right to see their own doctor if they want opposed to the Post Office appointed doctor. Beware some doctors are not too keen on OWCP cases, so you may be rejected at first by some.

Recently OWCP has made it easier to file a claim by going online with ECOMP web portal. This portal gives carriers the opportunity to file their claim and then follow up by tracking it through the process. They can also, upload other documents to add to their case. It is important to have all the facts of your case in time sequence order and stress it was in the performance of job. You need to state how the injury will affect your job moving forward.

Since the OWCP replaced the Post Office in handling of Employee Injury claims on the job, there has been a fairer procedure put in place opposed to the prejudging by Management. Now the right forms CA-1, CA-16, and CA-7 have to be submitted as soon as possible with all doctor's medical documents and Supervisors documents. This helps ensure the carrier has continuation of pay for first 60 days of the injury. Always keep your Union representative updated of your status. They may have knowledge of other sources for assistance.

Jim is a longtime active member with Branch 1690. He has served as a Shop Steward and Sargent at Arms.



How to Safely Wear and Take Off a Mask



WEAR YOUR MASK CORRECTLY

- · Wash your hands before putting on your mask
- · Put it over your nose and mouth and secure it under your chin
- Try to fit it snugly against the sides of your face
- · Make sure you can breathe easily
- Do not place a mask on a child younger than 2







USE A MASK TO HELP PROTECT OTHERS

- Wear a mask over your nose and mouth to help prevent getting and spreading COVID-19
- Wear a mask in public settings when around people who don't live
 in your household, especially when indoors and when it may be difficult
 for you to stay six feet apart from people who don't live with you
- Don't put the mask around your neck or up on your forehead

RULES FOR THE DOYLE ADAIR/BEATRICE TRAPP SCHOLARSHIP ASSISTANCE AWARD


